Standards Working Group

In June 2005 a workshop was held in Oxford at the Nuffield Orthopaedic Centre to discuss audit of gait labs. This was facilitated by staff from the clinical audit team at the Nuffield. During the session we focused on conducting an internal audit of compliance of the lab to the standards. Some initial audit sheets were put to-

gether by the group during the session. Following the session pairs that had worked on each standards audit sheet finalised this and they were all circulated to and agreed by the group.

These audit sheets have now been circulated to all labs and we have requested

that each lab should return three completed sheets by the end of November, together with any comments. This will be followed by another workshop in Oxford in January to address issues raised by this, discuss external audit and accreditation.

Three free months !

Membership

We have decided to move the membership renewal date from January to March to coincide with the AGM. This means that current members will have their membership extended.

We are also going to offer a membership and meeting fee combined, at a reduced rate, in order to encourage people to join up. The two will also be offered separately for those who wish to join CMAS without attending the meeting and vice versa.

Education and Training Subgroup

Education

Following the AGM in March, a working group was formed to consider issues relating to education and training. E-mail discussions and an informal meeting at the recent ESMAC conference followed. It was agreed by the members of the working group that CMAS should promote courses cover-

ing some or all of the educational areas raised in previous discussions, an example being the correspondence course in motion analysis that will be offered by Ms Sheila Gibbs and her colleagues from Dundee University from next year.

Training

With regards to training issues, Adam Shortland has produced a draft list of the competencies that would be useful for someone working in motion analysis. These are being considered by the working group and we hope to be able to report our progress in the next AGM.
